Incident

November 10th, 2022

7:00 am

Light Infantry Battalion (550) based in Pone Nar Kyunn and (344) based in Par Da Lape, Sittwe launched an assault on Padaythar Village and Sin Inn Gyi Village after three military trucks carrying supplies were attacked on the Yangon–Sittwe Road near Sin Inn Gyi Village and Padaythar Village, Pone Nar Kyunn Township. The assault included the use of jet fighters, drones, and heavy artilleries.

November 10th, 2022

12:15 pm

The military column with roughly 40 men from battalion (550) began ferociously firing towards Sin Inn Gyi village at around 12 o'clock in the afternoon. They entered the village in the evening, cursing the villagers and firing shots before shooting the homes while yelling, "Where is AA? Come outside." Ten people had died as a result of this attack, however one body hasn't been found yet. It's possible that some people were killed after being tortured because the knife wounds were discovered on some dead bodies.

Summary of Incident

The names of the victims are U Maung Maung Thein (Age 44), U Maung San Hla (Age 37), U Khin Maung (Age 57), U Maung Kyaw Thein (Age 62), U Kyaw Zan (Age 62), Daw Yine Nyunt Phyu (Age 87), Ma Khin Thein Myint (Age around 50), U Tun Thar Kyaw (Age 50), U Aye Tun Sein (Age around 60) and U Sayy Sayar (Age around 61).

Additionally, they started torching the houses, and 7 of them were burned to ashes. These homes are owned by Mg Tun Kyaing, U Tun Tin, Daw Ma Htay Tin, Daw Hlaing May Nu, Daw Than Aye Khin, and Daw Khin Bu.

Until now, he terrorist military forces have occupied the Sin Inn Gyi village with over a thousand residents and over 100 houses. In order to find shelter, the villagers fled to the adjacent villages because they were unable to return to their own.
